Saša Randelović



Saša Randelović je rođen 1982. godine, u Diseldorfu (Nemačka). Diplomirao je 2005. godine na Ekonomskom fakultetu Univerziteta u Beogradu, dok je 2008. godine magistrirao, a 2012. godine stekao doktorat iz ekonomskih nauka, na istom fakultetu.

Godine 2006. i 2007. bio je zaposlen u preduzeću KPMG d.o.o. Beograd na poslovima poreskog savetovanja. Od novembra 2007. zaposlen je na Ekonomskom fakultetu Univerziteta u Beogradu, prvo kao asistent, od 2013. kao docent, a od 2018. godine kao vanredni profesor, gde i danas radi. Od 2015. godine Saša Randelović je i prodekan za finansije i međunarodnu saradnju na istom fakultetu.

Saša Randelović je dobitnik nagrade za najbolju doktorsku disertaciju iz oblasti ekonomskih nauka u 2011-2012. godini u Srbiji, koju dodeljuje Naučno društvo ekonomista Srbije. U toku doktorskih studija Saša je 2010. godine boravio na Katoličkom Univerzitetu u Luvenu (Belgija), na osnovu Join-EU CEE stipendije. U 2016. godini boravio je na post-doktorskom istraživačkom usavršavanju na Slobodnom Univerzitetu u Berlinu (Nemačka). Od 2019. godine Saša Randelović je *visiting fellow* na Londonskoj školi ekonomije i političkih nauka (Evropski institut), a od 2020. godine je i gostujući profesor na Ekonomskom fakultetu Univerziteta u Zagrebu.

Uža oblast naučno-stručnog interesovanja Saše Randelovića su ekonomska, a posebno fiskalna politika i javne finansije, sa fokusom na pitanja iz oblasti oporezivanja, javnih investicija, sive ekonomije i nejednakosti. Saša je (ko)autor dve monografije, više desetina članaka objavljenih u međunarodnim naučnim časopisima (npr. *Economic Systems*, *Economics of Transition*, *International Journal of Microsimulation* i td.), međunarodnim monografijama i zbornicima radova sa konferencija.

Saša Randelović je član Srpskog fiskalnog društva i član upravnog odbora ovog udruženja, kao i Naučnog društva ekonomista Srbije. Takođe je i član Odbora za reviziju Banke Kine a.d. Beograd. Od septembra 2013. do jula 2014. godine Saša je bio angažovan kao eksterni visoki savetnik ministra finansija Republike Srbije za fiskalnu politiku. Bio je angažovan u većem broju radnih grupa Ministarstva finansija u vezi sa reformama fiskalnog sistema. Takođe je bio angažovan na većem broju projekata kao eksterni konsultant Fiskalnog Saveta Republike Srbije, a povremeno je angažovan i kao konsultant na projektima Svetske banke, UNDP, USAID i nemačke organizacije za međunarodnu saradnju GIZ. Saša je izvršni urednik Kvartalnog monitora ekonomskih trendova i politika u Srbiji.

Saša Ranđelović



Saša Ranđelović was born on 1982 in Dusseldorf (Germany). He graduated from the University of Belgrade – Faculty of Economics in 2005. In 2008 he obtained the master degree and in 2012 the PhD degree in economics, from the University of Belgrade – Faculty of Economics.

Saša Ranđelović was employed at the KPMG d.o.o. Beograd in 2006 and 2007, in tax advisory services. Since November 2007 he is employed at the University of Belgrade – at first as teaching assistant and from 2013 as assistant professor, while from 2018 as associate professor. From 2015 he is also the vice dean in charge of finance and international relations at the same faculty.

Saša Ranđelović won the prize for the best PhD thesis in economics in Serbia in 2011-2012, awarded by the Scientific Association of Economists of Serbia. During his PhD studies, Saša spent some time at the Catholic University of Leuven (Belgium) in 2010, based on the Join EU-SEE scholarship. In 2016 Saša Ranđelović was doing the post-doctoral research at the Free University of Berlin (Germany). From 2019 he is visiting fellow at the London School of Economics and Political Science – European Institute, while from 2020 he is appointed as the visiting professor at University of Zagreb – Faculty of Economics and Business.

His field of research include economic policy, with the focus on fiscal policy and public finance and specialization in the fields of taxation, public investment, shadow economy and inequality. Saša Ranđelović is (co)author of two books, a few dozens of articles published in the international journals (e.g. *Economic Systems*, *Economics of Transition*, *International Journal of Microsimulation*, etc.), international monographs and conference proceedings.

Saša is member of the International Fiscal Association (Serbian affiliate), and member of the managing board of this association, as well the member of the Scientific Association of Economists of Serbia. He is member of the Audit Committee of the Bank of China a.d. Beograd. From September 2013 to July 2014 Saša was engaged as external, high level fiscal policy advisor to the Minister of Finance of Serbia. From 2009 to 2015 Saša was engaged in several working groups, established by the Ministry of Finance, for fiscal system reforms in Serbia. He was also engaged on several projects as external consultant to the Fiscal Council of the Republic of Serbia. Saša Ranđelović is occasionally engaged by the World Bank, UNDP, USAID and GIZ, as external consultant. Saša is executive editor of the Quarterly Monitor of Economic Trends and Policies in Serbia.
